Publication of a transparency notification

(Article 14, first paragraph, of the Law of 2 May 2007 on disclosure of major holdings)

Summary of the notification

With reference to article 14 of the law of 2 May 2007 on disclosure of major holdings, Colruyt Group and its supervisory shareholder Korys have submitted a notification to the FSMA.

This transparency notification, dated 19 December 2022, proves that, as a result of the change of denominator by the capital increase reserved for Colruyt Group's personnel, Colruyt Group holds a total of 4,99% of the company's voting rights and thus fell below a legal threshold of 5%.

On 19 December 2022, Colruyt Group, together with Korys, Korys Investments, Korys Business Services I, II and III (excluding the Colruyt family and relatives acting in concert), hold a total of 81.395.270 Colruyt shares, together representing 60,71% of the total number of shares issued by the company (134.077.688).

The new denominator of 134.077.688 shares thus takes into account the capital increase 2022 reserved for Colruyt Group employees, for which a total of 238.500 new shares were issued by notarial deed on 19 December 2022.

This limited notification does not prejudice the existing mutual consultations between the Colruyt family and relatives, Korys, Colruyt Group.

The company has no knowledge of other agreements between shareholders. The statutory thresholds per 5% bracket apply.

Content of the notification

The notification dated 19/12/2022 contains the following information:

- Reason for the notification: downward crossing of a passive threshold by Korys and Colruyt Group



Additional information:

Following the change of denominator due to the capital increase reserved for Colruyt Group employees, Etn. Fr. Colruyt NV fell below a legal threshold of 5%.

Although Etn. Fr. Colruyt NV is no party to the agreements to act in concert, its treasury shares are included given its capacity of subsidiary of Korys NV (Art. 6, §5, 3° Transparency Law); Korys NV is indeed deemed to hold these shares indirectly.
