Subject: Notification of an agreement to act in concert by virtue of article 74 of the Law of 1 April 2007 - Update

Dear members of the Board of Directors,

In compliance with article 74 § 7 and § 8 of the Law of 1 April 2007 on public take-over bids (the "Law") we informed you on 18/02/2008 that a number of parties acting in concert jointly held more than 30 % of the voting securities issued by Colruyt Group NV (the "Company") on 1 September 2007.

Please find herewith an update as per 22/08/2025 of the different shareholdings in conformity with article 74 § 8 of the law mentioned above.

This notification is sent to you in the name and on account of all parties acting in concert.

The parties to this agreement to act in concert and their respective shareholdings are as follows:

Colruyt Group NV and subsidiaries are required to act in concert by virtue of article 3 §2 of the Law.

The total number of shares involved in this agreement to act in concert thus amounts to 96.929.907 or 77,86% of the Company shares outstanding as per 22 August 2025 (124.497.858).

Chain of controlled undertakings:

- Colruyt Group NV and its subsidiary CGMI BV are controlled by Korys NV, which in turn are controlled by Stichting Administratiekantoor Cozin.
- Korys Investments NV and Korys Management Investments BV are controlled by Korys NV
- Korys Business Services I NV, Korys Business Services II NV and Korys Business Services III NV are controlled by Korys NV.
- o Stiftung Pro Creatura, foundation under Swiss law, and Impact Capital NV are controlled by natural persons (who directly or indirectly hold less than 3% of the securities with voting rights of the Company).

Although Colruyt Group NV and its subsidiary CGMI BV are no party to the agreements to act in concert, those treasury shares are included given their capacity of subsidiaries of Korys NV (Art. 6, §5, 3° Transparency Law); Korys NV is indeed deemed to hold these shares indirectly.

All information contained herein reflects the situation as per 22 August 2025.
