In compliance with article 74 § 7 and § 8 of the Law of 1 April 2007 on public take-over bids (the "Law") we informed you on 18/02/2008 that a number of parties acting in concert jointly held more than 30 % of the voting securities issued by Etablissementen Fr. Colruyt N.V. (the "Company") on 1 September 2007.
