Dear members of the Board of Directors,

In compliance with article 74 § 7 and § 8 of the Law of 1 April 2007 on public take-over bids (the "Law") we informed you on 18/02/2008 that a number of parties acting in concert jointly held more than 30 % of the voting securities issued by Etablissementen Fr. Colruyt NV (the "Company") on 1 September 2007.

Please find herewith an update as per 26/08/2022 of the different shareholdings in conformity with article 74 § 8 of the law mentioned above.

This notification is sent to you in the name and on account of all parties acting in concert.

This does not affect the mutual consultation agreement between the Colruyt family and relatives.

Etablissementen Fr. Colruyt NV is required to act in concert by virtue of article 3 §2 of the Law.

The total number of shares involved in this agreement to act in concert thus amounts to 87.745.684 or 65,56% of Company shares outstanding as per 26 August 2022 (133.839.188).
