### **Publication of a transparency notification**

(article 14, first paragraph, of the Law of 2 May 2007 on disclosure of major holdings)

#### ***Summary of the notification***

Pursuant to article 14 of the Law of 2 May 2007 on disclosure of major holdings, Colruyt Group and its controlling shareholder Korys, together with the Colruyt family and relatives, have submitted a notification to the FSMA.

This transparency notification, dated 16 May 2023, shows that, as a result of the acquisition of its own Colruyt shares, Colruyt Group holds a total of 5,09% of the company's voting rights, thus exceeding a legal threshold of 5%.

The mutually acting shareholders Korys, Colruyt family and relatives together with Colruyt Group hold a total of 90.491.672 Colruyt shares on 16 May 2023, representing 67,49% of the total number of shares issued by the company (134.077.688).

The company has no knowledge of other agreements between shareholders. The statutory thresholds per 5% bracket apply.

  - Korys Investments NV and Korys Management Investments BV are controlled by Korys NV.
  - Korys Business Services I NV, Korys Business Services II NV and Korys Business Services III NV are controlled by Korys NV.
  - Stiftung Pro Creatura, foundation under Swiss law, and Impact Capital NV are controlled by natural persons (who directly or indirectly hold less than 3% of the securities with voting rights of the Company).

Following the buyback of its own shares, Colruyt Group exceeded a threshold of 5%.

Although Etn. Fr. Colruyt NV is no party to the agreements to act in concert, its treasury shares are included given its capacity of subsidiary of Korys NV (Art. 6, §5, 3° Transparency Law); Korys NV is indeed deemed to hold these shares indirectly.
