

What are the requirements for suppliers to work with Colruyt Group?

Introduction

Suppliers seeking to work with Colruyt Group must comply with all applicable requirements. This includes meeting quality standards for private label food and non-food products, adhering to social sustainability policies—such as signing and uploading the corporate social responsibility overview—and providing product information according to the specified guidelines.

1. Quality

Among other things, we expect each product to comply with national and European legislation and to have a technical data sheet. The supplier must also have GFSI-accredited food safety certification.

We also have specific views on additives and specific ingredients such as soy, palm oil, fish and coffee.

Colruyt Group needs correct product information for its internal operations, such as creating item numbers and controlling logistics. For the correct processing of product data, we work exclusively with GS1. As a supplier, you can register for the [‘My Product Manager’ van GS1 Belux](#).

Colruyt Group expects:

- a **complete and correct product sheet** including label information, logistical data, info for Green score calculations, any certificates ...;
- **timely publication** of data;
- an **easily readable and unique bar code** at each level of packaging, in accordance with the latest GS1 specifications.

6. Medical Devices

As a distributor of medical devices, Colruyt Group must comply with legal requirements. As a supplier, this means:

- You must indicate **which products** you consider to be medical devices.
- You must add the **required documents and information** to the digital product sheet:
 - FAMHP (FAGG) registration certificate
 - EU declaration of conformity
 - CE certificate
 - Labelling/packaging (PDF) and instructions for use
 - Shelf-life data and storage instructions
- All submitted information is verified by our **quality department**.
